DESCRIPTION OF AWARD

This award honours Dr Charles J.A. Hayes, a well-respected Psychologist whose career may be said to be a model of lifetime commitment. This award serves to recognize depth and engagement of long-term service and recognizes those who have spent a significant part of their professional lifetime supporting APNS, its member psychologists, and the profession of psychology at the provincial, national and international level. APNS will issue an annual Call for Nominations, however, the award may not be given every year. Any APNS member may nominate one person annually for this award. The honour is given based on the following criteria:

- Impact of the Nominee's contribution to psychology
- The description of the contribution(s)
- Demonstrable results of the contribution(s)
- Relative length of career time spent on these endeavours
- Amount of detail and examples provided in the nomination materials

6. List specific achievements, honours, or awards the Nominee received that are relevant to this award.
