

# **NOMINATION FORM: APNS Excellence in Psychology Award 2025**

**DEADLINE: Tuesday, April 1, 2025** 

### **DESCRIPTION OF AWARD**

This award focuses on excellence in the profession of Psychology. The recipient is an APNS member who is in midcareer (11 to 30-year range) who has demonstrated excellence in their professional activities or in their volunteer activities while acting as a Psychologist. The award may be given for work relating to: 1) area of practice (health, forensic, neuropsychology, addictions, assessment); 2) work setting (school, hospital, private practice, teaching, research); 3) population (child, teen, geriatric, couple, diverse groups, first responders, marginalized populations); 4) treatment area (PTSD, pain, grief, workplace); and 5) peer-related (supervision, mentoring, peer support, consultation, collaboration). The recipient will receive an award of \$1,500.

APNS will issue an annual Call for Nominations, however, the award may not be given every year. An APNS member may nominate only one APNS member annually for this award. The award is given based on the following criteria:

- Reason(s) for the nomination as given by the nominator in the nomination materials
- Depth of description as given by the nominator in the nomination materials.
- Demonstrable results of the contribution.
- Supporting evidence to the above by APNS or other relevant organizations or individuals.
- Length or portion of their career time spent on these endeavours
